- 2. Your broker should deliver the form to our agent, CIBC Investor Edge.

- 3. Once the securities have been transferred to Villa Cathay's brokerage account, CIBC Investor Edge will advise us in writing of the receipt of the securities and the closing bid value on the day the securities were received into our account.
- 4. Villa Cathay Care Home must receive the securities in its account before the securities can be valued and a charitable tax receipt can then be issued.
- 5. It is our policy that securities, once received by Villa Cathay or its broker, may be sold or added in specie to Villa Cathay's investment account in accordance with our investment policies.
